Privacy Policy and Terms of Service

Pragmedic Solutions, LLC takes your privacy seriously. Please read the following to learn more about our Privacy Policy and Terms of Service.

What This “Privacy Policy” and “Terms of Service” Covers

- This policy covers how Pragmedic Solutions, LLC treats personal information that Pragmedic Solutions, LLC collects and receives, including information related to your past use of Pragmedic Solutions, LLC products and services. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.
- This policy does not apply to the practices of companies that Pragmedic Solutions, LLC does not own or control or to people that Pragmedic Solutions, LLC does not employ or manage. In addition, certain Pragmedic Solutions, LLC associated companies such as Amatech Associates Inc., Perheal Pvt. Ltd., and Indispensable Communications Inc. have their own privacy statements which can be viewed on their respective websites.

Your Registration Obligations, Account Information and Data

In consideration of your use of the Service, you represent that you are not a person barred from receiving services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate and current information about yourself as prompted by the Service's registration form (the "Registration Data") and (b) maintain and promptly update the Registration Data to keep it current and updated.

If you provide any information that is untrue, inaccurate, not current or incomplete, or Pragmedic Solutions, LLC has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, Pragmedic Solutions, LLC has the right to suspend or terminate your account and refuse any and all current or future use of the Service (or any portion thereof). Pragmedic Solutions, LLC is concerned about the safety and privacy of all its customers.

You acknowledge, consent and agree that Pragmedic Solutions, LLC may access, preserve and disclose your account information and Content if required to do so by law or in a good faith belief that such access preservation or disclosure is reasonably necessary to: (a) comply with legal process; (b) enforce the Term of Service; (c) respond to claims that any Content violates the rights of third parties; (d) respond to your requests for customer service; or (e) protect the rights, property or personal safety of Pragmedic Solutions, LLC, its users and the public.

Indemnity

You agree to indemnify and hold Pragmedic Solutions, LLC and its subsidiaries, affiliates, officers, agents, employees, partners and licensors harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of Data you submit, transmit or otherwise make available through the Service, your use of the Service, your connection to the Service, your violation of the Terms of Service, or your violation of any rights of another.

No Resale of Services and Products

You agree not to reproduce, duplicate, copy, sell, trade, resell or exploit for any commercial purposes, any portion of the Services and Products (including your account ID), use of the Services and Products, or access to the Services and Products.

General Practices Regarding Use and Storage of your Clinical Data

You acknowledge that Pragmedic Solutions, LLC may establish general practices and limits concerning use of the Services and Products, including without limitation the maximum number of days that your Clinical Data, or other stored Content will be retained by the Service (Currently 3 Months are allowed for Trial Versions of Services and Products), the maximum disk space that will be allotted on Pragmedic Solutions, LLC's servers on your behalf, and the maximum number of days you may access the Service in a given period of time (Currently 30 Days are allowed for Trial Versions of Services and Products).

You agree that Pragmedic Solutions, LLC has no responsibility or liability for the deletion or failure to store any data or other Content maintained by the Service. You acknowledge that Pragmedic Solutions, LLC reserves the right to log off accounts that are inactive for an extended period of time. You further acknowledge that Pragmedic Solutions, LLC reserves the right to modify these general practices and limits from time to time.

Modifications to Service

Member Account, Password and Security

You will receive a password and account designation upon completing the Service's registration process. You are responsible for maintaining the confidentiality of the password and account and are fully responsible for all activities that occur under your

password or account. You agree to (a) immediately notify Pragmedic Solutions, LLC of any unauthorized use of your password or account or any other breach of security.

Pragmedic Solutions, LLC's Proprietary Rights

You acknowledge and agree that the Service and any necessary software used in connection with the Service ("Software") contain proprietary and confidential information that is protected by applicable intellectual property and other laws. You further acknowledge. Information Collection and Use

General

- Pragmedic Solutions, LLC collects personal information when you register with Pragmedic Solutions, LLC, when you use Pragmedic Solutions, LLC's products or services, and when you visit Pragmedic Solutions, LLC pages or the pages of certain Pragmedic Solutions, LLC partners. Pragmedic Solutions, LLC may combine information about you that we have with information we obtain from business partners or other companies.
- When you register we ask for information such as your name, email address, birth date, gender, zip code, occupation, industry, and personal interests. Once you register with Pragmedic Solutions, LLC and sign in to our services, you are not anonymous to us.
- Pragmedic Solutions, LLC collects information about your transactions with us and with some of our business partners, including information about your use of services that we offer.
- Pragmedic Solutions, LLC uses information for the following general purposes: to fulfill your requests for products and services, improve our services, contact you, conduct research, and generating research reports for internal and external clients.

Information Sharing and Disclosure

- Pragmedic Solutions, LLC does not rent, sell, or share personal information about you with other people or nonaffiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:
 - We provide the information to trusted partners who work on behalf of or with Pragmedic Solutions, LLC under confidentiality agreements. These companies may use your personal information to help Pragmedic Solutions, LLC communicate with you about offers from Pragmedic Solutions, LLC and our marketing partners. However, these companies do not have any independent right to share this information.
 - We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims;
 - We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Pragmedic Solutions, LLC's terms of use, or as otherwise required by law.
 - We transfer information about you if Pragmedic Solutions, LLC is acquired by or merged with another company. In this event, Pragmedic Solutions, LLC will notify you before information about you is transferred and becomes subject to a different privacy policy.
- Pragmedic Solutions, LLC works with vendors, partners, advertisers, and other service providers in different industries and categories of business.

Your Ability to Edit and Delete Your Account Information and Preferences

General
